Andrew Wylegala has served since 2023 as the President of the National Association of Japan-America Societies (NAJAS), the largest and oldest umbrella group of its type, covering a network of about 40 independent nonprofit societies with over 12,000 corporate and individual members. He promotes the hugely important U.S.-Japan relationship across various subject matters with a focus on people-to-people or "grassroots" ties.



Andrew had a far-ranging government career, from a start as a Presidential Management Fellow to culmination as a member of the U.S. Senior Foreign Service, serving in eight overseas posts, including Hong Kong, Seoul, and Tokyo, where he led a team of 40 from the U.S. Embassy as Minister Counselor for Commercial Affairs from 2012-2017. As a Professor of Practice at the National Defense University, he taught economics and industry analysis to security policy practitioners. From high school through graduate studies, Andrew developed his passion for Japan as a Rotary Exchange Student, a Japan-America Student Conference delegate and a Reischauer Center intern at the headquarters of Mitsui & Co. Andrew was also President of the American Chamber of Commerce in Taiwan, growing that organization through the challenges of the pandemic and Cross Strait tension. He is a graduate of Cornell University and S.A.I.S. and lives in Washington, D.C.
